Please read the following carefully. By purchasing this template you acknowledge that you agree with the terms of this contract.

I understand that I am purchasing a website template that I will edit myself, meaning I will import my own photos, text, links, etc. I understand that I will be provided with a detailed PDF document, as well as a video tutorial series on YouTube, that walks me through the editing process.

I understand and acknowledge that Wix.com offers extensive information regarding editing on their site and therefore, I will be responsible for referencing the links provided by Lily Girl Paper to find answers to editing questions. I understand that all images currently serving as placeholders on the website template belong to Amber Jones of Lily Girl Paper and must be replaced with my own images.

I acknowledge that the price of the template does not include my domain name registration and/or upgrading the site on Wix to a Premium subscription which will remove the small Wix ad banner from the top of the site. I understand that if I am not ready to pay for a website, I can keep the free Wix site with the ad in place, and understand that the URL will be siteprefix.wixsite.com/siteaddress; I know that I can change the site prefix and site address; i.e. lilygirlpaper.wixsite.com/lilygirlpaper.

I acknowledge that only the items shown on the sample website are included in the price of my template. If I want to add things such as email marketing, additional pages, etc., it will be my responsibility to add those items, or hire Amber Jones to do so at her current hourly rate.

I understand that this template cannot be imported into an existing website. If I have an existing site I acknowledge that I will need to copy and paste text and images from the original website to this new template.

I understand that either **before**, **or immediately after**, purchasing the template and signing this agreement I need to set up an account on Wix.com using the email address provided at checkout. Amber will begin the website transfer process within **1-2 business** days of my completed purchase. I will be notified by Wix once the transfer has been initiated. I acknowledge

that Wix requires me to accept the transfer within 3 days. If I fail to do so, I will contact Amber to transfer the site again at a fee of \$15.

I understand that this template is not one-of-a-kind and will be resold to other customers. This template is licensed for personal and business use only. It may not be resold, distributed, or claimed as an original design. The structure and design remain the intellectual property of Lily Girl Paper.

I understand that I will have the ability to change site colors, fonts, text and images easily with no coding needed.

I acknowledge that it is recommended that I make a copy of the template before editing in case I need to start over with the original template. (Instructions on how to do this will be provided in the YouTube video tutorials.)

I understand that this template can only be used on the Wix.com platform.

I acknowledge that website templates are non-refundable and all sales are final.

Once the website is transferred, Lily Girl Paper is not responsible for any issues arising from customer modifications, accidental deletions, or site malfunctions. Wix provides its own support for technical issues beyond template functionality.
